Cancellation Protection:

You may cancel the Protection Plan by giving us written notice within either fourteen (14) days from the date of issuance of Your protection plan, or Your Scheduled Departure Date whichever occurs first, provided You have not submitted a claim. If You do this, we will refund Your plan cost in full (less the \$8.00 administration fee). If past fourteen days, your plan cost is nonrefundable.
